

The Book-to-Action program gathered community members to discuss a timely book, meet the author, then volunteer for a organization that implemented the ideas community members read about.

Farm City is a national best-selling memoir about Novella Carpenter's experience running an urban farm in an abandoned lot in Oakland. On her small plot, Carpenter not only grows a wide variety of vegetables, but also raises bees, goats, rabbits, geese, and farmyard animals.

Novella Carpenter writes about urban farming and sustainable food production for various publications, including her blog, *Oakland Farm*. She studied with Michael Pollan at U.C. Berkeley's Graduate School of Journalism, and has written for *Mother Jones* and *Gate*. *Farm City* was named a best book in 2009 by the *New York Times* and other media.

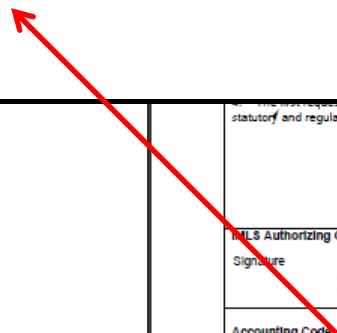

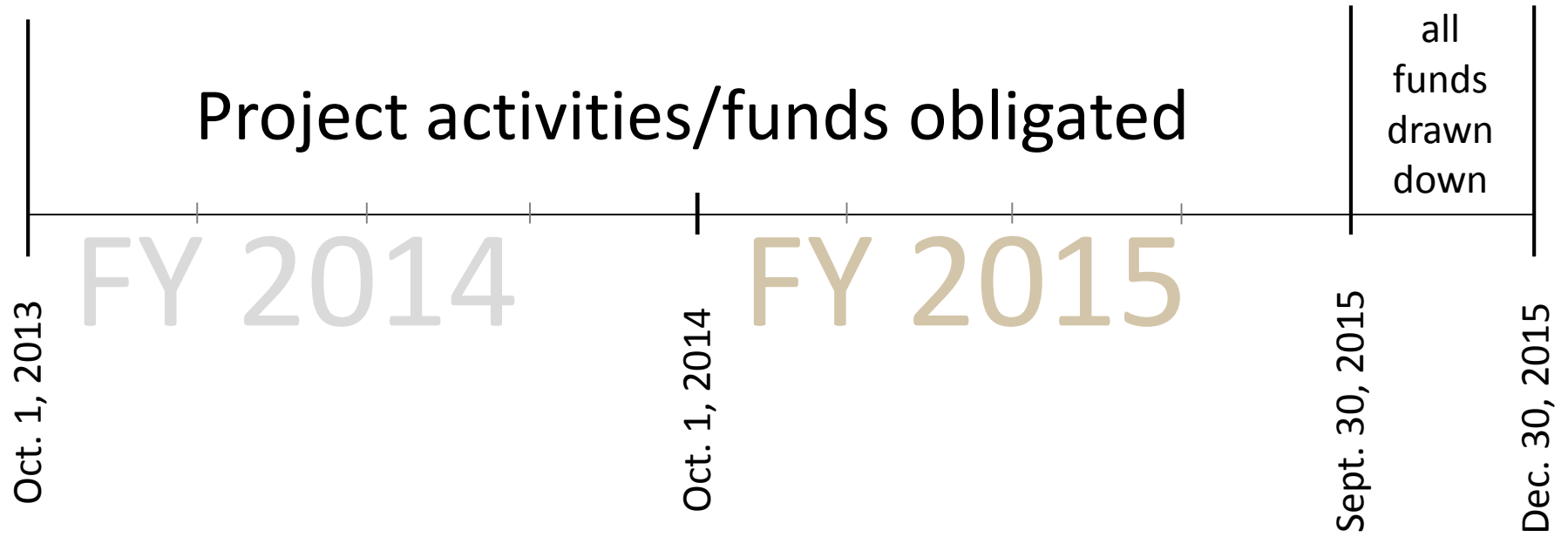

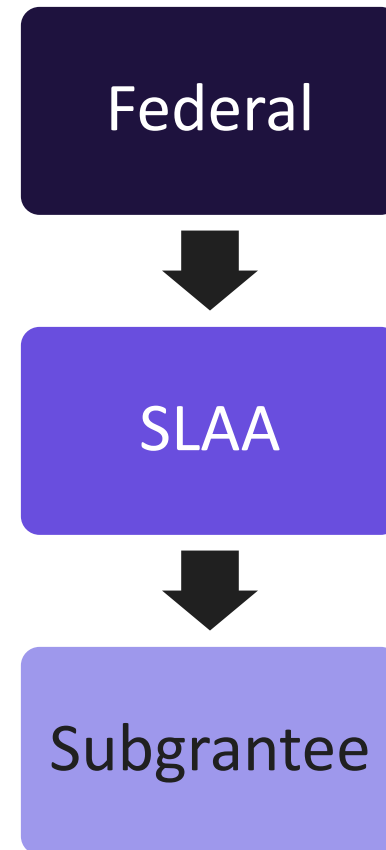
Five-Year Plan Revisions

- Only a change in goal(s) is considered substantive
- Need IMLS approval *before* implementing substantive changes
- Send request by April 1, 2014 to Program Officer for changes to be effective after October 1, 2014


