I. Introduction

The State Library Administrative Agencies (SLAA) Survey is a voluntary survey conducted biennially by the Institute of Museum and Library Services (IMLS). The SLAA Survey collects data on SLAAs in the 50 states and the District of Columbia. IMLS collects these data under the mandate in the **Museum and Library Services Act of 2018** (PL 115-410), as stated in Section 210.¹ The survey is a cooperative effort of the Chief Officers of State Library Agencies (COSLA); RTI International (RTI), the data collection agent; and IMLS.

The fiscal year (FY) 2020 survey is the 22nd in the series. The survey was put on a biennial administration schedule beginning with the FY 2010 survey; before then, it was administered annually.²

This user's guide provides detailed information on the SLAA data set pertaining to FY 2020. The data files include all SLAAs in the 50 states and the District of Columbia. The reporting unit for the survey is the SLAA. Each data file includes a total of 385 variables. Data files are available in SAS (.sas7bdat), comma-separated (.csv), and SPSS (.sav) formats. The data file record layout in Appendix A displays the layout of the data files and includes all of the variables contained therein.

Background

An SLAA is the official agency in a state with adequate authority under state law to administer state plans for libraries in accordance with the provisions of the Library Services and Technology Act (LSTA) (20 U.S.C. § 9121) of 2018. In addition to their critical role in assessing, planning, and coordinating library services and resources, SLAAs may provide important reference and information services to the state government, administer the state library or serve as the state archives, operate libraries for the blind and print disabled, and/or support the State Center for the Book. In some states, the SLAA also may function as a public library at large, providing library services to the general public.

Purpose of Survey

The purpose of the SLAA Survey is to provide state and federal policymakers and other interested users with information about SLAAs. The data collected are useful to chief officers of SLAAs; policymakers in the executive and legislative branches of federal and state governments; government and library administrators at the federal, state, and local levels; decision makers who use this survey to obtain information about services and fiscal practices; the American Library Association and its members or customers; library and public policy researchers; and the public, journalists, and others. The data collected on services provided by SLAAs to public, academic, school, and special libraries, as well as library cooperatives—when combined with the data

collected by the IMLS Public Libraries Survey and the National Center for Education Statistics surveys of academic and school libraries—provide a picture of library services that is comprehensive and nationwide in scope.

The legislative authorization to perform this data collection appears in Appendix B. IMLS library research activities are conducted in ongoing collaboration with SLAAs and other relevant agencies and organizations to extend and improve the nation's library and information services.

II. User's Guide to SLAA Data

Survey Methodology

Survey Universe

The survey universe comprises the SLAAs in the 50 states and the District of Columbia (51 total). There was no sampling: the SLAA is a census.

The respondents for the SLAA FY 2020 Survey were employed at each of the states' SLAAs. Chief officers of each SLAA assigned one or more respondents to provide data for the survey. Data were entered by the respondents and certified by the chief officers.

Web-Based Data Collection Tool and Questionnaire

The SLAA FY 2020 Survey data were collected in English over the Internet via a web-based reporting system. The web application included a user's guide and tutorial that explained its features and operation, the survey questionnaire, and a data edit check tool designed to alert respondents to anomalies or inconsistencies in their data entries. The web application was designed to minimize respondent burden, to improve data quality and timeliness, and to ensure that minimal edit follow-up would be required with state agencies to resolve data problems.

The FY 2020 survey collected data on items organized in 13 parts:

- A. SLAA Identification
- B. Governance
- C. Allied Operations, State Resource or Reference/Information Service Center, and State Center for the Book
- D. Services to Libraries and Library Cooperatives
- E. Public Service Hours, Outlets, and User Groups
- F. Collections
- G. Library Service Transactions
- H. Library Development Transactions
- I. Staff
- J. Revenue
- K. Expenditures
- L. LSTA State Program Expenditures
- M. Electronic Services and Information

Data items and definitions are provided in the survey questionnaire and the instructions for completing survey items. Additional information on the questionnaire is provided in Appendix C.

Reporting Period

The SLAA FY 2020 Survey requested that respondents report data for their respective state's 2020 fiscal year, except for the items in Part B (Governance) and Part I (Staff), for which respondents were requested to report data as of October 1, 2020. The 2020 fiscal year for most states was July 1, 2019, to June 30, 2020. Five SLAAs had fiscal years with other start and end dates:

- New York: April 1, 2019–March 31, 2020
- Texas: September 1, 2019–August 31, 2020
- Alabama, District of Columbia, and Michigan: October 1, 2019–September 30, 2020

Survey Response Rate

Unit Response

The SLAA FY 2020 Survey achieved a 100 percent unit response rate; all 51 SLAAs provided data.

Item Response

Item response rates were calculated by dividing the total number of SLAAs reporting data for an item by the total number of SLAAs in the survey universe to which that item was presented.³

With the exception of two items (GOVDOC and LIBVISITS), all items had item response rates of 100 percent. The item response rate for GOVDOC was 94 percent, and the item response rate for LIBVISITS was 96 percent.

Data Collection and Processing

Data Collection

The SLAA FY 2020 Survey was opened for data entry to SLAAs using the web-based tool beginning on January 11, 2021. The data collection was closed on March 19, 2021. RTI was the data processing agent for the survey and administered the web application, provided technical support to respondents, performed edit and nonresponse follow-up, and produced the data files and tabulations.

To reduce respondent burden, the survey was transmitted with prior-year data pre-entered for the state agency name and address (including Part A, A-10 through A-40) based on FY 2018 SLAA Survey data and for the chief officer (Part A, A-130 through A-170) and survey respondent (Part A, A-180 through A-220) based on contact files from stakeholder identification. The survey

instructions directed respondents to review the pre-entered data and to update any information that had changed since the FY 2018 survey administration. The system also displayed prior-year responses in a non-editable, display-only field for reference for the following: Part E, E-101 through E-080; Part F, F-010 through F-050; Part J, J-070 through J-150; and all of parts G, H, I, K, and L.⁴ All other data cells were left blank for respondents to complete. All items required a response except those that followed a logical skip pattern. The system would not allow the respondent to submit and "lock" data unless the respondent answered or provided a justification as to why an answer was not available.

Data Processing

To ensure accuracy, data were checked and edited as necessary during and after collection. In addition, missing values were imputed (see details below).

Data elements collected about the state officer and the respondent (names and contact information included in Part A of the questionnaire) and other data elements associated with administrative data collection processes were removed from the final public data file.

Edit Checks During Data Collection

The web-based data collection tool alerted respondents to potential errors in the data during the data entry process through interactive edit check warnings. The respondent was required to address these warnings through an edit check report, which could be viewed on-screen or printed. The edit check tool enabled the respondent to submit an edited data file to RTI that typically required minimal follow-up to resolve data problems. The edit check tool included three types of edits:

- Relational edit checks (data consistency checks between related data elements). For example, an edit message was generated if the SLAA was designated as a federal depository library, but the respondent did not enter data for the item on the type of federal depository library.
- Out-of-range edit checks (comparisons of data reported for an item to the "plausible range" of numeric values). For example, an edit message was generated if the respondent entered a value less than 0.5 for annual circulation transactions per annual library visit.
- Blank/zero/invalid edit checks (checks of reported data against acceptable values). For example, an edit message was generated if the respondent entered a value of 0 for the data element on the number of book/serial volumes.

Respondents were required to address all edit check warnings in the web-based data collection tool prior to submitting (or "locking") their data.

⁴ Data fields that stored a numeric value generally included a read-only display of the value entered for FY 2018, but text fields and radio buttons did not. To assist with data collection and entry, respondents could print their last survey pre-populated with their FY 2018 responses.

Post-Edit Processing

After respondents locked their data, RTI performed additional edit checks or post-lock processing on the data (e.g., a comparison of the sum of the reported detail to a reported total). In previous survey administrations, if an SLAA's data failed any post-edit tests, RTI delivered an edit report to the respondent for further data editing and cleaning. Respondents were asked to correct the data or to verify the data as correct. RTI analysts incorporated the edited data into the data file. This year, only two issues needed to be addressed:

- South Dakota: reported "Other Agency" for LARGERAG and then filled "Department of Education" into OTHAGSP. LARGERAG was recoded to "Department of Education" and OTHAGSP was set to "LOGICAL SKIP."
- District of Columbia: follow-up correspondence confirmed that, like the other 50 SLAAs, the DC SLAA does collect public library statistics. The value of "N Not Provided" originally assigned for COLLBSTA was changed to "D Directly."

In addition, responses to the seven FIOTHnA items regarding sources of federal revenue and the associated FIOTHnB dollar amount variables were consolidated and coded into new variables. The following four yes/no indicator variables were constructed to cover the most frequent FIOTH responses: FIOTH_IMLSCARES, FIOTH_IMLSOTH, FIOTH_NEH, and FIOTH_NHPRC. Any remaining responses were captured in reformulated FIOTH1A-FIOTH3A variables. More detail on the assignment of FIOTH variables is provided in Appendix D.

Finally, minor changes were made to correct obvious typographical errors and to harmonize text variables.

Imputation

Imputation was performed for two numerical variables that had missing values, as shown in Table 1. In some cases, the states involved also had missing values in FY 2018. Values are marked in Table 1 as being "Imputed" or "Reported." Growth rate imputation of missing values was used in alignment with prior SLAA surveys. Values for FY 2018 were multiplied by variable-specific growth factors calculated as the mean of the FY 2020/FY 2018 ratios over all states for which both FY 2018 and FY 2020 values were present.

Two associated imputation flag variables, GOVDOC_F and LIBVISITS_F, were added to the data set. Each takes the value "GR18" (growth factor) for states with imputed values based on reported values in FY 2018, "GI18" for those for which the value was imputed using the growth model applied to data imputed in FY 2018, and "R" for data as reported by the respondent.

Other Variables Added During Post-Edit Processing

Three additional variables were added to the data files to aid users in performing common analyses, including those that are presented in the FY 2020 statistical tables, which report per capita metrics as well as data for four groups of SLAAs based on location within their jurisdictions' government.

Region: The variable named OBEREGION is made up of the U.S. Bureau of Economic Analysis's regions as shown in Table 2.

State Population: The variable named POPU_ST is the resident population derived from the 2020 decennial census.⁵

Administrative Structure Groups: The variable named ADMINGROUP was developed based on Bertot and White's 2014 study of state library agencies' governance, operations, and organization, with some slight modifications.⁶ Two of the six categories described by Bertot and White were the same (i.e., "Department of Education" and "Other Department"), but the other four were recombined into two categories for this variable, as follows:

A. Rather than being divided into two separate categories, the two SLAAs within the legislative branch and SLAAs in independent agencies were combined into a category labeled *"Independent Agency/Legislative Branch"* because Bertot and White found that

independent agencies were more likely to have the ability to advocate directly with legislative staff, much like SLAAs housed within the legislative branch itself.

B. Because departments of state and departments of administration tend to serve largely the same function, providing basic administrative services such as capital procurement and personnel management, Bertot and White's two separate categories were combined into one, labeled "Department of State/Administration."

The structure of administrative groups is described in Appendix F, and the assignment of SLAAs to administrative locations based on the responses to the four variables (BRANCH, INDAGY, LARGERAG, and OTHAGSP) is summarized in the table and figure in Appendix G.

Metadata Warehouse

Information received from states during the edit check warning process and the post-edit process was archived to create a metadata warehouse. IMLS and RTI reviewed these metadata to select information that may be useful to analysts.

Nonsampling Error

Because all units in the universe were surveyed, these data are not subject to sampling error. However, the SLAA data are subject to nonsampling error, such as measurement and processing errors. Every effort has been made to mitigate such errors. The editing efforts described above are designed to decrease the number of errors due to inaccurate responses or processing problems. Imputation lessens the effect of nonresponse. Extensive quality control checks were performed, iteratively, by both RTI and IMLS.

Disclosure Limitation

The SLAA public data files contain no personally identifiable information (PII),⁷ but they do contain potentially sensitive information in the form of salary and benefits expenditures for those SLAAs with few employees. However, only the District of Columbia (6 full-time equivalent [FTE] staff) and Hawaii (4 FTE staff) have fewer than 10 FTE staff. IMLS policy does not require that associated expenditures be suppressed or altered to protect confidentiality.⁸

Using the Data

SLAA Public Use Data File

IMLS provides one public use data file for this survey (slaa2020). The data file is provided in multiple formats: SAS (.sas7bdat), comma-delimited (.csv), and SPSS (.sav). The SLAA FY 2020

public use data file consists of 51 records (observations), one for each SLAA. The data file has 385 variables, including imputation flags.

Comparisons of FY 2020 Data to Prior-Year Data

Missing data were imputed beginning with the FY 1999 survey. Data users should take into consideration that items that include imputations are not strictly comparable to data from surveys prior to FY 1999.

State comparisons should be made with caution because states vary in their fiscal year reporting periods and may vary in their interpretation of the survey items. Also, the District of Columbia, although not a state, is included in the survey.

Changes to FY 2020 Data Collection

Between the FY 2018 and FY 2020 data collection cycles, several items were added to the survey instrument to address the impact of the COVID-19 coronavirus pandemic. The COVID-19-related variables will be released in a separate supplemental file with accompanying documentation. Aside from those additions, no changes were implemented to the remainder of the survey items between the FY 2018 and FY 2020 SLAA data collections.

For FY 2020, the web data collection system also included a new feature that automatically calculated totals for most of the fields that are sums of other fields. The total values were displayed on-screen to assist with data entry and saved as variable values in back-end data. Respondents did not have to manually calculate the values and enter them.

Appendix B—Legislative Authorization

IMLS collects these data as authorized by its congressional mandate, the Museum and Library Services Act of 2018, as stated in 20 U.S.C. § 9108 (Policy research, data collection, analysis and modeling, evaluation, and dissemination):

(a) In general

The Director shall regularly support and conduct, as appropriate, policy research, data collection, analysis and modeling, evaluation, and dissemination of information to extend and improve the Nation's museum, library, and information services.

(b) Objectives

The objectives of the policy research, data collection, analysis and modeling, evaluation, and dissemination of information carried out under this section include the following:

- (1) To enhance and expand the capacity of museums, libraries, and information services to anticipate, respond to, and meet the evolving needs of communities and the public, including by identifying trends and developments that may impact the need for and delivery of services.
- (2) To provide information and data on the role, value, and impact of museum, library, and information resources, including the identification of trends and potential gaps in the availability and use of museum and library services by their communities and the public.
- (3) To measure the effectiveness of museums, libraries, and information services throughout the United States, including the impact of Federal programs authorized under this Act.
- (4) To identify indicators and outcomes that can be used to create enhancements to the efficiency and efficacy of museum, library, and information services.
- (5) To promote advancement and growth in museum, library, and information services through sharing of best practices and effective strategies in order to better serve the people of the United States.
- (6) To facilitate planning for, and building of, institutional capacity in order to improve—
 (A) museum, library, and information services at the national, State, local, and regional levels; and(B) international communications and cooperative networks.
- (7) To support and enhance collaborative professional networks and consortia that use shared, meaningful, and actionable data analysis and modeling to advance museum, library, and information services and address community needs.
- (c) Authority to contract and enter into other arrangements

The Director is authorized to enter into grants, contracts, cooperative agreements, and other arrangements with Federal agencies, public and private organizations, and other entities with expertise the Director determines appropriate, to further the objectives described in subsection (b) and to carry out the responsibilities under subsection (f).

(d) Consultation and Public Engagement

In carrying out subsection (a) and in furtherance of the objectives described in subsection (b), the Director—

- (1) shall conduct ongoing collaboration (as determined appropriate by the Director) and consult with—
 - (A) State library administrative agencies; and
 - (B) National, State, tribal, and regional museum and library organizations; and
- (2) may also collaborate or consult with-
 - (A) cooperative networks of geographic- or discipline-based museums and libraries; and
 - (B) other applicable agencies, organizations (including international organizations), entities (including entities with expertise in the fields of data collection, analysis and modeling, and evaluation), and community stakeholders.
- (e) Assistance to museums and libraries

The Director shall provide technical support and assistance (and other resources, to the extent practicable) to ensure consistency in data reporting and help the museum and library fields with meeting the objectives of this section.

- (f) Dissemination
 - (1) In general-
 - (2) Each year, the Director shall widely disseminate, as appropriate to further the objectives described in subsection (b)—
 - (A) the results, data, reports, findings, studies, surveys, and other information obtained under this section;
 - (B) the means and approaches by which the objectives described in subsection (b) were accomplished; and
 - (C) information regarding the manner and extent to which collaboration and consultation were conducted, as required by subsection (d).
 - (3) Formats to be used-

The information described in paragraph (1) shall be shared in formats that facilitate access and ease of use and are searchable.

- (g) Authorization of appropriations
 - (1) In general

There are authorized to be appropriated to carry out this section \$3,500,000 for each of the fiscal years 2020 through 2025.

(2) Availability of funds

Sums appropriated under paragraph (1) for any fiscal year shall remain available for obligation until expended.

However, the percentages included in Table E1 reflect inclusion of all cases and do not report "valid percentages" that would be produced given the missing values declarations.




Figure G1. The Resulting SLAA Administrative Structure Groups for FY 2020
