Overview

- OLS-ORE plan to evaluate G2S CARES/ARPA grants
 - Examine only Grants-to-States
 - Est \$208 million in awards
- Desire to investigate use and efficiency of funds, identify lessons learned, and understand gaps in post-recovery activities

Draft scope for CARES/ARPA evaluation


- Goal: review the administrative processes and distribution/use of CARES/ARPA by SLAAs
- Methods: potential focus groups, interviews, and/or a survey of SLAA staff, library workers, and selected statelevel officials
- Deliverables: evaluation report of findings and communications assets
 - PPTs, infographics, and one-page summaries of key learnings
- **Timeline**: 2023-2024 (~July 2024 end date)

CARES Act project budgets dominated by Supplies, Services


CARES budget categories of over \$1 million

 - Online reading


CARES funded areas (by projects)

December 2022 Discussion with COSLA

Topics with chiefs:

- Shared feedback from June Conference
- States desire further discussion on administering stimulus funds during an emergency
- Strong interest in telling the post-recovery story from the states' eyes
- IMLS perspective: leveraging state-federal partnership



Draft research questions: CARES/ARPA

- In what ways did libraries use the funds to respond to the pandemic – different modalities (PPE, outdoor furniture)?
- How did the funds advance technology access and what are the gaps after the funds are spent?
- What local, state, and federal lessons learned from successes and failures can be used to improve existing and future funding from IMLS?



Draft hypotheses: CARES/ARPA

- The smaller rollout of IMLS G2S CARES Act prepared SLAAs and IMLS for the larger roll-out of ARPA
- SLAAs with more staff capacity had an easier time spending down/distributing funds
- SLAAs with existing subaward programs had less of a lift in getting these funds out the door
- Centralized purchasing came with pros and cons; more onerous processes nonetheless yielded efficiencies of cost/scale
- Funds were handled efficiently and used to support communities in need
